ouncil recognized by it, and will hold no communication whatever in Scottish Rite Masonry with any member of th	ie
ame nor allow him to visit any Body of the Rite of which I may be a member; and I will dispense justice to my Brethro	'n
ccording to the laws of equity and honor.
